1<sup>st</sup> & 2<sup>nd</sup> Placers in the FEMALE Divisions advance to the State Championships in Johnstown and receive a Medal and Uniform.

## 2026 RELEASE AND WAIVER OF LIABILITY AGREEMENT & PARTICIPANT CODE OF CONDUCT

I am voluntarily participating with knowledge of the danger involved and agree to assume any and all risks of bodily injury, or death, whether those risks are known or unknown.

1. Entry fee covers entry requirements and insurance. Fee is \$35.00. Plus \$2.50 online registration fee.
2. To be eligible for the Junior High division, a wrestler must be able to be on a Junior Eligibility List for their school. Home schooled and private school wrestlers must meet same requirements even though they do not participate on a public-school team.
3. P.I.A.A. rules will govern all matches except as follows:
  - A. All bouts will consist of three periods of 1 ½ - 1 ½ - 1 ½ minutes.  
OVERTIME: 1-minute Sudden Death period. Two-30 second Rideouts, if needed. 30-second Ultimate Rideout, if needed, with choice going to first score in regulation.
  - B. HEADGEAR IS REQUIRED IN ALL PJW TOURNAMENTS.
  - C. IF A WRESTLER USES A HAIR COVER IT MUST BE ONE THAT IS ATTACHED TO THE HEAD GEAR.
  - D. PIAA RULE REGARDING THE SECURING OF SHOELACES IS TO BE ENFORCED IN ALL PJW TOURNAMENTS. LACES MUST BE SECURED TO THE SHOE EITHER BY DOUBLE KNOT, TAPE, OR VELCRO STRIPS.
  - E. MOUTH GUARDS FOR WRESTLERS WITH BRACES WILL BE REQUIRED AGAIN THIS YEAR.
4. Participants must weigh in at the weight class they have entered. There will be no shifting of weights or substitutions at weigh-in time or no weight allowance. Entrants not making weight will be scratched. At the PJW State Junior High Tournament all wrestlers who advance to Sunday MUST weigh-in again on Sunday with a 2 lb. weight allowance.
5. Any wrestler who is 12 years of age and wrestles on a school's Junior High Team may enter either the Jr. High age division or the Youth division, BUT NOT BOTH. This applies to females as well.
6. FEMALES MUST ENTER THE FEMALE DIVISION. ONLY exception would be any female weighing more than maximum of 222 lbs. may move up to the male division in the appropriate weight class.
7. Participants may enter one weight class only.
8. The maximum weight class (252 lbs. for Males and 222 lbs. for Females) will include all wrestlers whose weight is more than the preceding weight class (212 lbs. for Males and 182 lbs. for Females).
9. Birth certificates or copies of birth certificates will be required of all Area finalists at the Area Tournament, and for all wrestlers competing in the State Championship Tournament.
10. The source of rules governing this tournament will be the P.I.A.A. Rule Book, the Pennsylvania Junior Wrestling Rules Booklet, and the Area Rules that apply to the operation of the qualifying tournament.
11. Only fulltime residents of Pennsylvania may enter the Pennsylvania Junior Wrestling tournaments.
12. The hair rule for the Pennsylvania Junior Wrestling tournaments will be enforced as defined in the National Federation Rules Book and adopted by the P.I.A.A.
13. Counties eligible in Area V include Cameron, Clarion, Clearfield, Elk, Jefferson, McKean, and Potter.
14. ALL PARTICIPANTS AND THEIR PARENT(S) OR GUARDIAN(S) MUST SIGN THE LIABILITY WAIVER AND CODE OF CONDUCT FORM. PLEASE KEEP IT ATTACHED TO THE APPLICATION.
15. **ALL WRESTLERS ADVANCING TO THE STATE CHAMPIONSHIPS IN JOHNSTOWN MUST PAY A \$50 ADVANCEMENT/UNIFORM FEE. \$50 FEE WILL BE COLLECTED WHEN UNIFORMS ARE PICKED UP AFTER THE FINALS IN CLEARFIELD.**
